#### 1. Introduction

GrabGram ("we," "our," or "us") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and protect your information when you use our Service.

#### 2. Information We Collect

#### 2.1 Information You Provide

- Email Address: Collected only when you purchase a paid subscription
- Telegram User ID: Used to provide the Service through our bot
- Payment Information: Processed directly by our payment provider (Lava.top)

#### 2.2 Automatically Collected Information

- Analytics Data: We use Google Analytics to understand Service usage
- . Website Analytics: Our landing page uses analytics platforms to track visits
- . Bot Interaction Data: Commands and interactions with our Telegram bot

#### 2.3 Content Data

- We process only publicly available content from links you provide
- · We do not access or store any private information
- · Content is delivered to you via Telegram and not permanently stored by us

#### 3. How We Use Your Information

We use collected information to:

- · Provide and improve our Service
- · Process your subscription payments
- · Send service-related notifications
- · Analyze usage patterns to enhance user experience
- · Comply with legal obligations

## 4. Information Sharing

We share your information only as follows:

- Payment Processor (Lava.top): Your email address for payment processing
- · Analytics Providers: Anonymized usage data
- Legal Requirements: If required by law or legal process
- Your Consent: With your explicit permission

We do NOT:

- · Sell your personal information
- · Share your data with advertisers
- · Use your data for purposes unrelated to the Service

## 5. Data Security

We implement appropriate technical and organizational measures to protect your information, including:

- · Encrypted data transmission
- · Limited access to personal information
- · Regular security assessments

However, no method of transmission over the Internet is 100% secure.

- Email Addresses: Retained while your subscription is active and for legal compliance
- Analytics Data: Retained according to Google Analytics policies
- . Content: Not permanently stored; delivered directly to your Telegram
